## Newsworthy Items in November!

In each issue of the *Patriot Perspective* we will summarize the events of the previous month that directly effect Americans, their rights and our country. This last month has been one of turmoil on many fronts. In this issue we will touch on some of the more pertinent news items to American liberty and inalienable rights.

### Judge Roy Moore Removed From Chief Justice Post

A judicial panel ruled that Alabama Chief Justice Roy Moore be removed from his position for disobeying a judge's orders to remove a Ten Commandments display from the state courthouse. Moore said he was removed from his job for acknowledging God and he further stated, "Without an acknowledgement of God, I cannot do my duties. I must acknowledge God. It says so in the constitution of Alabama. It says so in the First Amendment to the United States Constitution. It says so in everything I have read."

### Bush Visit to London Prompts Massive Protests and Heightened Security

President Bush's arrival in London was greeted with mass protests and the London Police were put on high alerts sparked by terror concerns increasing their numbers to 14,000 officers. Just prior to his arrival, anti-war demonstrators led by former U.S. Marine Ron Kovic, author of "Born on the Fourth of July", was joined by several anti-war members of Blair's Labor Party when he delivered a petition to Prime Minister Tony Blair exhorting the government to call off Bush's visit. Seemingly unaffected by the protests, President Bush said, "I'm not concerned at all. I'm glad to be going to a free country where people are allowed to protest." Upon arriving, the crowd of protesters, estimated in the tens of thousands, tore down a "statue" of President Bush in London's Trafalgar Square. One protester passed out biblical literature proclaiming that the president "isn't a true Christian" while another protester, Jo Smith, accused Bush and Blair of only "paying lip service to democracy." In Bush's keynote speech, he outlined his 'Three Pillars' of Security saying that cooperation with international institutions, the willingness to use force and the encouragement of democracy were the vital elements of global security.

### **Arnold Schwarzenegger Sworn in as California's 38th Governor**

Republican Arnold Schwarzenegger took the oath of office to become the new governor of the traditionally liberal state of California. He then promised, "I took the oath to serve you, I will not forget my oath, and I will not forget you." His first act in office was to sign a repeal of the 300% increase in the state's car tax that many believe began the recall of former Governor Gray Davis.

### **Rush Limbaugh Comes Out of Drug Rehab**

Controversial talk-show host, Rush Limbaugh returned to the air after completing a 30-day stay in a drug rehab center for prescription painkiller addiction. Liberals had jumped on the opportunity to find fault with the right-wing host and were saddened that he was allowed to return to the airwaves. His first rebuttal came in the form of a lambasting of his critics saying, "Many people think that when you go to rehabilitation center for addictions or other things that the people in there turn you into a linguine-spined liberal, and that's not true." He said no one made an effort to change his views.

### **Democrats Tout 2nd Amendment in an Attempt to Swing Southern Votes**

Major Democratic candidates have toned down their stance on firearms in attempt to sway gun owners, while assuring liberals of their continued support for gun control. In effect, they are trying to burn the candle at both ends. The current Democratic frontrunner, former Vermont Gov. Howard Dean, has repeatedly stressed his endorsements from the National Rifle Association, while serving as Vermont's governor, in an attempt to reach out to pro-gun Democrats. The other contenders, retired Gen. Wesley Clark, U.S. Rep. Dick Gephardt of Missouri and U.S. Sen. Joe Lieberman of Connecticut, are also trying to play both sides.

### **Massachusetts Court Approves Same-Sex Marriage**

The Massachusetts Supreme Judicial Court has just pronounced a very controversial decision changing the longstanding definition of marriage as the union of one man and one woman. In a 4-3 ruling, the opinion reads "there's nothing in the Massachusetts constitution to prevent seven same-sex couples from enjoying the legal right to marry in the commonwealth". They further said, "The question before us is whether, consistent with the Massachusetts Constitution, the Commonwealth may deny the protections, benefits and obligations conferred by civil marriage to two individuals of the same sex who wish to marry. We conclude that it may not." In response, three Republican Senators have introduced a "Federal Marriage Amendment". This proposed constitutional amendment defines marriage as the union of one man and one woman. "Americans believe that gays and lesbians have a right to live as they choose, but they don't have a right to redefine marriage for our entire society," said Matt Daniels, president of the Alliance for Marriage. This follows on the heels of the "Federal Marriage Amendment" introduced in May of this year in the House with 100 co-sponsors.

## *The New Originalist Movement*

Recently, Supreme Court Justices Clarence Thomas and Antonin Scalia have proclaimed themselves Originalists rather than Constitutionalists. The thought on this change is based on the current derogatory stereotype by the mainstream media of Constitutionalists as illiterate, beer-drinking, anti-government wackos.

Anyone who has studied and researched the Constitution and all the history to determine the obvious intent of our founding fathers would obviously prove this stereotype a fallacy. However, the move to the term "Originalist" is a good one as it implies the return to the values, ethics, morals and intent of the Original founders.

This battle of ideologies began among law professors in the eighties when Edwin Meese and Robert Bork proposed that the Constitution be interpreted according to the original intentions of its framers.

Originalism has not only survived the debates of the eighties, but it has triumphed over its rivals. Originalism is now the prevailing approach to constitutional interpretation. For example, arguments interpreting the Second Amendment as protecting an individual right are almost exclusively originalist and now carry more weight than the highly implausible version of that intent—that the Second Amendment originally was intended to protect, not an individual right, but the organized militias that have since been superceded by the state National Guard.

For the benefit of Americans and our posterity, the constitutional text can now be looked upon as the sole legitimate source of operative norms of constitutional law. The text itself authorizes the use of unwritten sources through provisions like the ninth amendment. This is the phrase that concerns all those unenumerated rights which seem to have been lost in the shuffle.

The shift to originalism was made much easier, and perhaps even possible, by law professors' discovery of the neorepublican historical scholarship on the founding era, such as that by Gordon Wood.

The influential work of Bruce Ackerman in the eighties and nineties, culminated in *We the People: Foundations* in 1991 and then with *We the People: Transformations* in 1998. He wrote:

*"It is not the special province of the judges to lead the People onward and upward to new and higher values... What the judges are especially equipped to do is preserve the achievements of popular sovereignty during the long periods of our public existence when the citizenry is not mobilized for great constitutional achievements. Respecting popular sovereignty means respecting judgments made by the People in the past. This ongoing judicial effort to look backward and interpret the meaning of the great achievements of the past is an indispensable part of the larger project of distinguishing the will of **We the People** from the acts of **We the Politicians**."*

Originalism has itself changed—from original intention to original meaning. No longer

do originalists claim to be seeking the subjective intentions of the framers. Now Robert Bork, Clarence Thomas and Antonin Scalia seek the original meaning of the text. As stated by Robert Bork:

*“Though I have written of the understanding of the ratifiers of the Constitution, since they enacted it and made it law, that is actually a shorthand formulation, because what the ratifiers understood themselves to be enacting must be taken to be **what the public of that time would have understood the words to mean**. It is important to be clear about this. The search is not for a subjective intention. When lawmakers use words, the law that results is what those words ordinarily mean.*

By the same token Justice Scalia has written that *“...we look for a sort of 'objectified' intent—the intent that a reasonable person would gather from the text of the law, placed alongside the remainder of the corpus juris .... **Government by unexpressed intent is ... tyrannical**. It is the law that governs, not the intent of the lawgiver.”*

In constitutional interpretation, the shift is from the original intentions or will of the lawmakers, to the objective original meaning that a reasonable listener of that time would place on the words used in the constitutional provision at the time of its enactment.

This is an enormous change for attorneys and judges!

This means that rather than basing their decisions on detailed legislative history (*“stare decisis”*) they will have to find references to dictionaries, common contemporary meanings, and logical inferences from the structure and general purposes of the text from the time of the constitutional enactment!

This movement to originalism will carry with it another priceless change. It would ultimately restore the values and ethics of our legal environment. The reason for this is that looking for original meaning will carry with it the spiritual values and morality that was so prevalent in the 1700's have lost their focus in the 1900's and this new millennium. All one has to do is look around to see this is true.

***There Is A Sorrow Here That Weeping Cannot Symbolize

Muley Graves, character in John Steinbeck's, *The Grapes of Wrath* said, "I'm right here to tell you, mister, there ain't nobody gonna push me off my land! My grandpaw took up this land seventy years ago. My paw was born here. We was all born on it. An' some of us was killed on it. An' some of us died on it. That's what makes it arn. Bein' born on it and workin' on it and dyin', dyin' on it. An' not no piece of paper with writin' on it."

The plight of the dispossessed Joad family in *The Grapes of Wrath* was universalized as a microcosm of the thousands of farm families who suffered oppression imposed by the banks and big farm interests.

The family's departure from their land, and their slow disintegration provided insight into the thousands of Oklahoma, Colorado, Texas Panhandle, and West Kansas families who were evicted and uprooted from their land, and forced to search westward in the inhospitable Eden of California for jobs and survival. Steinbeck's, *The Grapes of Wrath*, laid bare the suffering and oppression of the farmers, and the hollowness of the American Dream. The telling novel questioned issues of social and economic justice and brought them to the attention of the America public.

For the past two decades, a dispossession in America, dwarfing that encountered by Steinbeck in the California labor camps, has been silently slithering across the nation. The new rural cleansing encompasses almost every state.

Country people have been denied their livelihoods and effectively pushed from their soil as surely the Joads. Instead of these folks being driven from the land by such easily identifiable villains as "banks and big farm interests," today's dispossessed are destroyed by regulatory agencies, dubious science, special interests and obscenely rich foundations.

If Steinbeck wrote a novel on the forced relocation of farmers today, it likely would never be printed because of environmental politics. The destruction of rural America has been aided and abetted by an unwitting urban public. A society that has their views molded by a prejudiced and convoluted media applaud the forced relocation of farmers, miners, ranchers, loggers and other resource providers in the name of "saving the planet," for spotted birds, lizards and insignificant little fish. Because of silence in the press and outright censorship, the plight of those forced to relocate has gone unnoticed.

Oswald Spengler wrote in 1939, "The press is free to take notice of what he says or not. It can condemn any "truth" to death simply by not undertaking its communication to the world -- a terrible censorship of silence, which is all the more potent in that the masses of newspaper readers are absolutely unaware that it exists."

necessary for anyone to fight again against the censorship of the press. We have a censorship by the press."

## ***Gold, Our Economy and the Threat To Your Money***

For Americans forced to use Federal Reserve Notes (U.S. money) or those who have been concerned with the state of our economy, it is time to take a long hard look at obtaining gold and start converting as much of your U.S. money to it as you can!

There has been a great deal of concern over the U.S. dollar losing value against the Euro. I will point out that the REAL problem is NOT the Euro, but not having a gold-backed currency!

Despite the U.S. military successes in Iraq, the U.S. dollar's value has not strengthened as currency traders had expected. The U.S., as the only remaining 'superpower' has only maintained domination in the world based on two factors:

1. Its overwhelming military superiority.
2. Its control of world economic flows by maintaining the role of the dollar as the basis of the world's reserve currency.

It is clear that both the war in Afghanistan and Iraq were about preserving the latter, maintaining the role of the U.S. dollar in International commerce! But there is a fly in the ointment that we are not hearing in the mainstream media, and it has nothing to do with the Euro!

The Muslim world has found a novel way to strike back at the West – or at least at Western bankers who rule the world's currencies – introduce a gold coin. As of August of this year, Malaysia began to use gold dinars in all trade between Islamic countries. Other Muslim countries are also following suit. The gold dinar, which is 4.25 grams of 24-carat gold, is expected to unite Muslim nations who blame "greedy" currency traders for Asia's downfall in the economic crisis of 1997–98. There is also a silver Islamic Dirham coin of 3.0 grams silver. The dinar is currently being used in 22 countries and is minted in 4 countries.

The Malaysian premier, Prime Minister Mahathir Modamad, spearheaded this move last year in November when he proposed that the gold dinar would eliminate paper money which has no intrinsic value and would cease making exchange rates arbitrary and subject to manipulation as seen during the Asian financial crisis. "The risk of speculation can be reduced to almost nothing. World trade can actually expand because the cost of business will be much reduced as the need to hedge will practically disappear," said Modamad.

The Islamic world has historically used a gold coin, the Dinar. Imad-ad-Dean Ahmad says, "Muslims cannot escape the fact that gold is our money. Instead of fighting the will of Allah, I propose that we embrace it. If the one billion Muslims of the world would use gold as their unit of account the volatility would stabilize."

The result of a gold-backed currency in the world could cause the US dollar to crash in value. Some suggest the gold dinar would cause a shift in economic power from

the West to the East. Trading in Islamic dinars has recently been opened on the Internet.

This is not a new occurrence. Since the end of World War II, there have been several distinct changes in the role of the U.S. dollar in the world. The role of the dollar was directly tied to that of gold. So long as America enjoyed the largest gold reserves, and the U.S. economy was far the most productive and efficient producer. Organizations of elites, such as the Bilderberg meetings, were organized to gain the same advantages and share the wealth with Europe. By the early 1970's, the Bretton Woods Gold Exchange began to break down, as Europe got on its feet economically and U.S. gold reserves were being transferred to Europe and especially to the International Monetary Fund (IMF). The growing economic strength of Western Europe, not surprisingly, coincided with soaring U.S. public deficits.

All during the 1960's, France, under Charles de Gaulle, began to take its dollar export earnings and demand gold from the U.S. Federal Reserve, which was legal under the Bretton Woods agreement. France was not the only country to do so. Other central banks increased their call for U.S. gold in exchange for their dollar reserves.

By May 1971 the drain of U.S. Federal Reserve gold was alarming. Even the Bank of England joined the French in demanding U.S. gold for their dollars. The Nixon Administration opted to abandon gold entirely. This removed the restraints on printing new dollars. The limit was only how many dollars the rest of the world would take. This second disastrous change, handed control over American monetary policy to large international banks such as Citibank, Chase Manhattan or Barclays Bank. Beginning in the mid-1970's, the U.S. system of global economic dominance underwent a dramatic change based on Oil.

Before going further, I will re-emphasize the crucial fact that Muslim countries, including all the OPEC countries, have maintained a gold-backed currency while those countries involved in the IMF and World Trade Organization (WTO) have switched to fiat (non-gold backed) currencies. Oil **importing** countries around the world were all forced to pay their expensive new oil import bills, predominantly with fiat money. OPEC oil countries were flooded with new oil dollars. A large share of these oil dollars came to London and New York (i.e., IMF controlled Federal Reserve) banks where a new process was instituted in May 1971 at the Bilderberger meeting in Saltsjoebaden, Sweden.

OPEC was suddenly flooded with dollars it could not or, more likely, **would not** use. U.S. and UK banks took the OPEC dollars and exchanged them for Eurodollar bonds or loans to countries of the Third World desperate to borrow dollars to finance their oil imports.

## ***Gold, Our Economy and the Threat To Your Money-Continued***

The buildup of these petrodollar debts by the late 1970's laid the basis for the Third World debt crisis in the 1980's. Hundreds of billions of dollars were exchanged between OPEC, the London and New York banks and back to Third World borrowing countries.

The Third World debt crisis began when the U.S. Federal Reserve unilaterally hiked U.S. interest rates in late 1979 to try to save the failing dollar. After three years of record high U.S. interest rates, the dollar was 'saved', but the entire third world was choking economically under usurious U.S. interest rates on their petrodollar loans. By August 1982, Mexico announced it would default on repaying loans. To enforce debt repayment to the London and New York banks, the banks brought the IMF in to act as 'debt policeman'. Public spending for health, education, welfare was slashed on IMF orders to ensure the banks got timely debt service on their petrodollars. Now you see why our education system began failing in the late 1970's!

The IMF 'Washington Consensus' was developed to enforce draconian debt collection on Third World countries, to force them to repay dollar debts, prevent any economic independence from the nations of the South, and keep the U.S. banks and the dollar afloat.

Japan had recently emerged as an industrial nation and major importer of oil. David Rockefeller and others, in an attempt to bring Japan into the system, created the Trilateral Commission in 1973. Japanese trade surpluses from export of cars and other goods was used to buy oil in dollars. The remaining surplus was invested in U.S. Treasury bonds to earn interest. The G-7 was founded to keep Japan and Western Europe inside the U.S. dollar system. Japan tried on several occasions to get the IMF to use three currencies; the U.S. dollar, the German mark and the yen, to share the world reserve role. It was never allowed and the U.S. dollar remained dominant.

In 1976, at the IMF Jamaica Accords, gold was demonetized for all countries who had signed their “Articles of Agreement” in order to keep the value of gold down in regards to their fiat currency. In response, U.S. gold reserves have been set at a value of \$42.222 per ounce by statute (See U.S. Treasury website). What this means is that all the gold trading that our government does is currently at a value much lower than the current market rate of \$396.50 (as of 11-27-03). This means that trading done with U.S. gold to other countries is at our statutory rate and NOT market value. See where our wealth is going?

Saudi Arabia has become the most recent recipient of Pakistani nuclear technology transfers. This follows the discoveries that Pakistan has continued its support of Islamic militancy in the Philippines and potential terrorism elsewhere.

According to Selig S. Harrison, a prominent U.S. Asia expert and the Asia director of the Center for International Policy, it is now common knowledge that Gen. Musharraf helped North Korea with uranium enrichment technology transfers in return for missiles. "The CIA gathered incontrovertible proof that U.S.-supplied C-130 transport planes were used to ship six Nodong missiles from North Korea to the AQ Khan research laboratories in March."

Once again, let us remember that all of these countries use gold-back currency.

No OPEC country dared to violate the requirement to trade their oil using the U.S. dollar until November 2000 when the French and other European Union countries *supposedly* convinced Saddam Hussein to defy the United States by selling Iraq's oil-for-food not in dollars, 'the enemy currency' as Iraq named it, but only in euros.

I purposely placed “supposedly” in italics for this reason. The U.S. Dollar has steadily dropped in value in relation to the Euro and would have been ample justification for the United States to pick this particular time to invade Iraq and depose Saddam Hussein. However, there is even more important justification that would propel us into war with Iraq.

Remember that Muslim countries and other far east countries believe in gold, gold-backed currency and resent the IMF/FED/WTO system of fractional reserve banking (or more easily termed “floating currency”) and always have. It has now come to light that these countries have been working on a long-term plan to profit from this system as long as they could and then remove themselves completely from it!

As Saudi Arabia has 60% of the world’s oil reserves, they were in the pre-eminent position to accomplish this goal but for one factor, they did not have nuclear capability until just recently! This, of course, is a threat large enough to prevent imperialistic countries from invading.

Therefore, the first step to move their plan along would be to have another Muslim, oil-producing country take the first step. Logically this would be Iraq.

Saddam Hussein has been a target of the U.S. since before the 1991 Gulf War. He has repeatedly tried to provoke the U.S. while attempting to maintain an image of solid adherence to Muslim principles.

Therefore, when Iraq leaked plans to defy the dollar in favor of the euro, their impetus was to create a panic situation. The concerns of the FED and IMF were, if the move to the euro spread through OPEC countries, there could be a panic sell-off of U.S. dollars by foreign central banks and OPEC oil producers. This would thus devastate the already weakening dollar.

Saddam was not alone in spreading this rumor. In the months prior to the latest Iraq war, the same rumors were heard from Russia, Iran, Indonesia and even Venezuela. An Iranian OPEC official, Javad Yarjani, delivered a detailed analysis of how OPEC at some future point might sell its oil to the EU for euros not dollars. He spoke in April, 2002 in Oviedo Spain at the invitation of the EU.

Many researchers have put out articles stating that the Iraq war was seized on as the easiest way to deliver a warning to OPEC and others, not to flirt with abandoning the U.S. dollar in favor of the euro. Was this part of the Muslim overall plan as well?

Saudi Arabia, at least up until now, has followed the IMF/FED requirements to trade in U.S. dollars. This devalued dollar has enabled the Saudi's to purchase gold (of which they had very little) with their profits in oil sales in order to obtain lasting value for their rapidly depleting oil reserves. Saudis believe that once their oil is gone, which is an inevitable reality in the long term, they don't want dollars. They would much prefer gold.

In our next issue of *Patriot Perspective*, I will continue with further issues regarding the IMF and FED's activities to curtail the inevitable drop in value of the U.S. dollar. In the meantime, I would strongly suggest that Americans consider buying gold as it will ultimately be the best means to protect your financial viability. Lastly, one small hint. If you buy old gold coins (over 100 years old) for investment, it doesn't have to be reported to the IRS!
