## The Core of the "Homosexual Marriage" Issue

*Or ...How the State Has Revealed It's Truth*

**Editor's Note:** *The following is a compilation from the emails of Alfred Adask . With his permission, I have edited this piece because I felt his message was too important to not be published quickly. Government does not license "marriages"-- it licenses marriage RELATIONSHIPS. There's a difference.

A biblical "marriage" is not the same as a "marriage relationship". A biblical "marriage" is under God (not the State) and results in two (a man and woman) becoming "one flesh".

On the other hand, a state-licensed "marriage RELATIONSHIP" results in two (man and woman) becoming three (man, woman and government administrator) entangled in a three-party "relationship"--a bizarre "ménage a trois" which includes one man, one woman and one artificial entity (corporation).

It is a maxim of law that all "relationships" are legal fictions. Legal fictions are lies. The Bible declares Satan to be the father of all lies. If the Bible is true, a legal fiction/lie must be under Satan rather than under God.

If so, a state-licensed "marriage relationship" can't be a biblical "marriage". Instead, the "marriage relationship" is a legal fiction, a lie, and absolutely and properly subjects it to government regulation. Folks should see that the state-licensed marriage is ungodly. They should inevitably ask why didn't their priest and ministers warn them...i.e., why did the churches go along with the marriage license program? The answer is that churches didn't protect against these ungodly marriages because the 26 USC 501(c) 3 "churches" are STATE churches and not churches of God.

The truth is that the homosexuals are right: there's no legal reason why homosexuals should be prevented from entering into the same state-licensed "marriage relationships" as heterosexuals--and we can expect the courts to correctly rule that way in the near future. Homosexuals have the same "right" to

enter into the legal fiction (lie) of a "marriage RELATIONSHIP" as a man and woman . . . or a man and a dog . . . or two women and a man. The list goes on. The state has never licensed "marriages"--it only licenses people to cohabit, to shack up, and to engage in the pretense of marriage, but not the real marriage as found in the Bible. (\*See **West v. West** below)

The point is NOT that homosexuals are suddenly getting the same "marriage" as heterosexuals, but that heterosexuals have (for generations) been unwittingly receiving the same state-licensed "marriage RELATIONSHIPS" as are now afforded to homosexuals. I.e., if you have a state-licensed "marriage relationship," you and your spouse are no more bound thereby in a GODLY "marriage" than a couple of queers shacking up in Massachusetts.

Truly, homosexuals cannot enter into a biblical "marriage" (where two become "one flesh"). Their recent "advances" in securing the "right" to enter into "marriage relationships" have no more spiritual significance than my "right" to dress up in a cape and pretend I'm "Batman". Both pretenses are equally fictional. No matter how many capes and cowls I don, I'm not really Batman. Likewise, no matter how many state-licensed marriage relationships the homosexuals engage in, they aren't really "married".

Even so, the recent homosexual "advances" in securing the privilege to enter into "marriage relationships" may ultimately be a good thing because it may help expose ALL state-licensed marriages as legal fictions, lies, and ungodly. Their movement to gain the "right" to marriage RELATIONSHIPS is not a degradation of the principles of true, biblical "marriage," but an exposure of the false nature of our modern, state-licensed, legal-fiction "relationships".

Ultimately, large numbers of spiritual people may realize that modern, state-licensed "marriage relationships" are at least ungodly (and arguably Satanic). As a result, many people may revoke their state-licensed, fictional "marriage relationships" and seek true marriages under God. They may begin to see that government uses the marriage-relationship LICENSE to gain control over all members of the family (especially the children) through "family" and/or "domestic relations" law. Folks may even conclude that by revoking their state-licensed marriage relationships, they may regain some personal freedom and rights of control over their own children.

As folks begin to learn that state-licensed "marriage RELATIONSHIPS" are fictions promoted by government to oppress the people, folks may likewise begin to see that the 501(c)(3), state-licensed "churches" are also ungodly. Ultimately, seeing that state-licensed "marriage relationships" and state-licensed "churches" are ungodly, folks may even begin to doubt the validity of other licenses and collectivist government in general.

Thus, a renewed appreciation for true marriage and the true church could flow from understanding the true nature of state-licensed "marriage relationships" recently extended to homosexuals.

The homosexuals will NEVER receive a Godly "marriage" nor can government decree otherwise--and government knows it. All government can do is give the homosexuals the same "right" to enter into a fictional marriage RELATIONSHIP as is already provided to ignorant heterosexuals.

However, as soon as heterosexual couples understand the nature of "marriage relationships," they'll see that their own licensed "marriage relationships" are no different from and not the least bit superior to the ungodly "marriage relationships" now provided to homosexuals under the guise of state licenses. The equivalence of the heterosexual and homosexual "marriage relationships" will reveal that both "relationships" are fictional and potentially "hazardous to your spiritual health".

As some people (a remnant, perhaps) begin to see the truth about Godly marriage" (as revealed, ironically, by the exposure of the "marriage relationships" provided by the ungodly homosexual community), they may begin to "come out of her," turn back to God, and seek salvation. God appears to be using the ungodly homosexuals to expose ungodly government, diminish that government's powers, and free the "elect" to choose to turn back towards Him.

As for the various cries from Congressmen and Senators for a constitutional amendment to expressly define marriage to be ONLY the union of one man to one woman--that won't happen any time soon. evident, . . .”), the democracy's denial of such rights inevitably implies the denial of God. Because both parties embrace democracy and thus, implicitly deny God, they are truly two "evils". Sometimes the Republicans are the lesser of the two evils; sometimes the Democrats. But, because both parties embrace democracy, they are always EVIL. We do routinely vote for the "lesser of two evils" so this old cliché is more insightful and intuitive than most imagine.

This issue is absolutely explosive and properly advanced may do more to raise public awareness of government corruption and treachery than anything seen since the Warren Report. The homosexual marriage issue is big enough to threaten the foundations of the existing government!

When people who are serious about their faith realize that our government has been promoting UNGODLY, three-party "marriage relationships" for most of a century, (thus INTENTIONALLY depriving us of Godly marriages) they will be ready to riot. Maybe even tear down the Congress, White House and state capitols.

*Some of the relevant statements by the Court in West v West are pulled out for review. Al's comments are in bracketed blue. -- TxS:*

### **West v West No. 5-97-0108 In the Appellate Court of Illinois Fifth District.**

"...Ginger begins her argument with a discussion of *the long-recognized constitutionally protected interest of parents to raise their children without undue State influence*. See Meyer v. Nebraska, 262 U.S. 390, 399, 67 L. Ed. 1042, 43 S. Ct. 625, 626 (1923); Pierce v. Society of the Sisters of the Holy Names of Jesus & Mary, 268 U.S. 510, 534-35, 69 L. Ed. 1070, 45 S. Ct. 571-73 (1925); Prince v. Massachusetts, 321 U.S. 158, 166, 88 L. Ed. 645, 64 S. Ct. 438, 442 (1944); Wisconsin v. Yoder, 406 U.S. 205, 235, 32 L. Ed. 2d 15, 92 S. Ct. 1526, 1543 (1972); Santosky v. Kramer, 455 U.S. 745, 753, 71 L. Ed. 2d 599, 102 S. Ct. 1388, 1394 (1982). However, this constitutionally protected parental *interest is not wholly without limit or beyond regulation*. Prince v. Commonwealth of Massachusetts, 321 U.S. 158, 166, 88 L. Ed. 645, 64 S. Ct. 438, 442 (1944). "[T]he state has a wide range of *power for limiting parental freedom and authority in things affecting the child's welfare*." Prince, 321 U.S. at 167, 88 L. Ed. 645, 64 S. Ct. at 442. In fact, the *entire familial relationship involves the State*.

When two people decide to get married, they are required to first procure a *license* from the State. If they have children of *this [licensed] marriage*, they are *required* by the State to *submit* their *children* to certain things, such as school attendance and vaccinations. Furthermore, *if at some time in the future the couple decides the [licensed] marriage is not working, they must petition the State*

for a divorce.

**[Licensed]** Marriage is a *three-party contract* between the man, the woman, and the *State*. **Linneman v. Linneman**, 1 Ill. App. 2d 48, 50, 116 N.E.2d 182, 183 (1953), citing **Van Koten v. Van Koten**, 323 Ill. 323, 326, 154 N. E. 146 (1926). The *State represents the public interest in the institution [relationship? Entity? Legal fiction?]* of marriage. **Linneman**, 1 Ill. App. 2d at 50, 116 N.E.2d at 183. This *public interest* is what *allows the State to intervene* in certain situations to protect the *interests* of *members* of the *family*. **[The “public” probably doesn’t get an “interest” in a “marriage” until that “marriage” is first licensed by the Public/State and becomes a “marriage relationship”. . . . I doubt that marriage is truly a “contract” except as defined in Restatement of Contracts and thus a trust.]** The State is like a *silent partner* in the family who is not active in the everyday running of the family but becomes active and exercises its *power and authority* only when *necessary to protect* some important *interest* of family life. Taking all of this into consideration, *the question no longer is whether the State has an interest or place [as representative of some “interest”]* in disputes such as the one at bar, but it becomes a question of *timing and necessity*. Has the State intervened *too early* or perhaps intervened where *no* intervention was *warranted*? This question then directs our discussion to an analysis of the provision of the Act that allows the challenged State intervention (750 ILCS 5/607(b) (West 1996)). . . .”

Government has used state-licensed "marriage relationships" to screw with people's faith or most of a century. This is no accident or misunderstanding or temporary mistake. This is an ongoing treachery. Once this reality is fully understood, people will be shocked and then enraged and then galvanized to ACTION. They will realize their government has intentionally deprived them of Godly marriages, and done so to gain power over the American families (especially children).

The Constitution declares that the federal government shall only have those rights and powers expressly delegated—all else are retained by the people or the states of the Union. But what *kind* of rights have been delegated to the government? I.e., is it even possible for us to “delegate” our unalienable Rights to government? I don’t think it is. If so, we can only delegate our inferior “human,” or “personal” or “civil” rights—but not our superior (sovereign) “unalienable Rights”. If that’s so, then our perfect unalienable Rights should always trump any government “interest” (or even right). How does government get around that maxim? By tricking us into changing our status from that of “men” to “persons,” “citizens,” or some such. Only men have unalienable Rights. So long as they can deceive us into appearing at court in some capacity other than “men,” they can ignore the issue of unalienable Rights since we are not in a status to claim them.

Some fundamental truths are harder to accept and believe than others. The really difficult ones are crossroads in our maturation, our understanding of the world we live in. This is similar to the messages and symbology found in the movie, *The Matrix*.

As a common point of understanding, when most discover that Santa Clause is no other than your Mother and Father, and it is they who are the ones bringing you presents, this is an epiphany, a crossroads. This is an acceptable trade-off between fiction and reality.

However, events like learning that your parents are getting a divorce is an earthquake that can shake your world and can affect your perception of how the world works for the rest of your life. How money is brought into being by the FED has everything to do with the kind of society we have and that society's impact on the rights and freedoms we rely on. It's time for Americans to wake up to the truth, no matter how hard they try to ignore it.

The foundations of fiat money creation are based, not on valid economic arguments but on the greed of the most powerful elite in the world, the International Bankers. This was foretold by Austrian Economists, Ludwig Von Mises and Nobel Peace Prize winner, Frederick Hayek as early as the 1940's. It was proven by the collapse of the economy in the U.S.S.R.

## ***Blackstone on “Inalienable” Rights***

Sir William Blackstone wrote “Commentaries on the Laws of England” in 1765. This work was the authoritative guide commonly used by our founders in determining the definitions and determinations of law that our system was founded on. Our own U.S. Supreme Court held it as the highest legal authority to guide their decisions until the Civil War (or if you prefer, the war of Northern Aggression) when they replaced it with Bouvier’s Law Dictionary as their primary reference.

The writings of Blackstone are still cited in cases today. It is therefore, important to understand that when Thomas Jefferson talked about “inalienable rights” in the Declaration of Independence, he added the adjective “inalienable” for absolute clarity. He wanted to leave no possibility for misinterpretation by future generations. He was referring to “natural rights”, endowed by our Creator as so ably defined in the following original and intended definition.

*“Those rights, then, which God and nature have established, and are therefore called natural rights, such as life and liberty, need not the aid of human laws to be more effectually invested in every man than they are; neither do they receive any additional strength when declared by the municipal laws to be inviolate. On the contrary, no human legislature has power to abridge or destroy them, unless the owner shall himself commit some act that amounts to a forfeiture.”*

-- Sir William Blackstone, Commentaries on the Laws of England 1765

These natural rights, being so obviously numerous and extensive, were unable to be listed in the Bill of Rights and therefore, the 9th Amendment (Article) was established to cover the rest.

### **Bill of Rights - Article IX**

*“The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.”*

It is time that we take a personal accounting of all of those inalienable, natural rights and remember they are ours from birth and NO Act of Human Legislature can take them away or infringe upon them!!! Can you name them? Can you teach your children what they are?

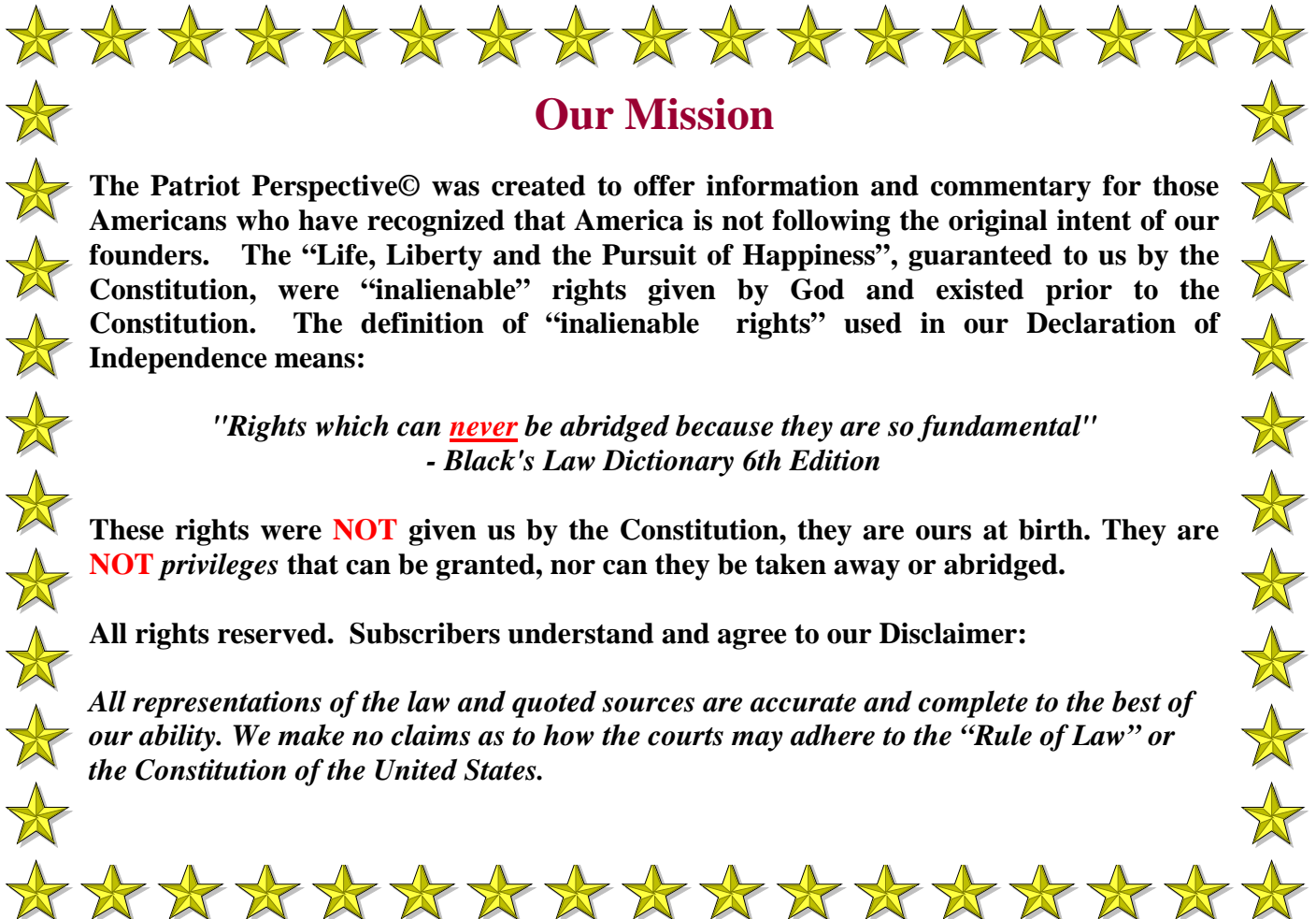
